



ORDER UNDER SECTION 14 OF THE COMMISSIONS OF INQUIRY ACT 1995 (TAS)

Date of order: 30 August 2023

THE COMMISSION NOTES THAT:

- A. By order dated 15 March 2021, Her Excellency Professor The Honourable Kate Warner AC established the Commission of Inquiry into the Tasmanian Government's Response to Child Sexual Abuse in Institutional Settings (**Commission**) under section 4 of the *Commissions of Inquiry Act 1995 (Tas) (Act)*.¹
- B. In making this Order, the Commission is satisfied under section 14(1) of the Act that any public interest in the public reporting or publishing of the evidence set out in this Order is outweighed by other relevant considerations, namely the privacy of personal affairs and the right of any person to a fair trial.

THE COMMISSION ORDERS THAT:

- 1 Under section 14(1) of the Act, any information or evidence given to the Commission which may identify the individuals who are listed in Schedule 1 to this Order is not to be published other than in accordance with the Commission's directions and to:
- (a) an individual who is listed in Schedule 1, to the extent that information relates to that given individual;
 - (b) any Counsel or solicitors retained by an individual identified in paragraph (a), to the extent that information relates to that given individual;
 - (c) the State of Tasmania, and any Counsel and solicitors retained by the State; and
 - (d) Counsel Assisting and the lawyers and staff assisting the Commission.
